# Community Focus Federal Credit Union

We have been pursuing a merger with Community Focus Federal Credit Union for nearly two years. Community Focus Federal Credit Union has applied to convert to a State-Chartered Credit Union, because with the Federal Charter we have not been able to define a geographic field of membership that meets the needs of both credit unions. This process is expected to take another two to three months.

The merger is of critical importance. While both credit unions are financially strong, they are relatively small sized, and the merger will provide the resources necessary to meet regulatory compliance, achieve significant loan and membership growth, and further improve the services that we provide to members

This is a challenging process, and we will strive to keep you informed about this.
